Please note that, although an attorney has listed a general area of law, he or she may not handle all issues related to that general area of law.

<u>ACCIDENT CASES:</u>	Generally includes automobile and work-related accidents, slip and fall, and other personal injury cases
<u>BANKRUPTCY LAW</u>	Generally relates to the process wherein a person, who, upon his or her own petition, or that of his or her creditors, is judged insolvent by a court. Additionally, whose property is administered for and divided among his or her creditors under a bankruptcy law.
<u>BUSINESS LAW:</u>	Fictitious name filings and partnerships, business contracts
<u>CIVIL LITIGATION:</u>	Generally includes products liability, medical and dental malpractice, wrongful discharge, employment discrimination, property line disputes
<u>DEBTOR/CREDITOR:</u>	Generally includes debtor/creditor suits, District Justice hearings, negotiations with creditors, bankruptcy, and reorganization
<u>EDUCATION LAW</u>	Relates to schools, school systems and school boards, student rights and movements. Generally refers to the collection of laws or rules that govern the operation of education systems.
<u>EMPLOYMENT LAW:</u>	Generally includes Workmen's Compensation, Unemployment Compensation, Industrial Disease claims, and asbestos claims
<u>ENVIRONMENTAL LAW:</u>	Generally includes environmental disputes or agency appearances
<u>FAMILY LAW:</u>	Generally includes separation, divorce, custody, support, adoption and abuse
<u>LANDLORD/TENANT:</u>	Generally includes disputes, evictions, lockouts, self-help evictions, and District Justice hearings
<u>OIL AND GAS</u>	Includes Leasing, Right of Ways, and Litigation
<u>PATENT LAW:</u>	Includes patents and trademarks
<u>REAL ESTATE:</u>	Generally includes purchase or sale of real estate, zoning and subdivision law, and mineral rights
<u>SOCIAL SECURITY LAW:</u>	Generally includes social security claims and appeals
<u>SUMMARY & CRIMINAL LAW:</u>	Generally includes representation of persons charged with criminal offenses and traffic violations, including DUI
<u>TAX LAW:</u>	Generally includes all Federal or State Tax matters
<u>WILLS AND ESTATES:</u>	Generally includes drafting a Will and/or estate plan, handling administration of estates, preparation of Living wills, Powers of Attorney, and guardianships.
