---

**From Route 422 West (New Castle):**

Exit Route 422 East at the Butler (Route 8 South) Exit. Take Route 8 South down the hill into the city. Turn right onto West Jefferson Street. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.

---

**From Route 422 East (Kittaning):**

Exit Route 422 West at the Jefferson Street (Route 68) Exit. Turn left and take Route 68 West across the bridge. Follow Route 68 (Jefferson Street) into the city. Continue straight across the Main Street intersection. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.

---

**From Route 68 East (Chicora):**

Take Route 68 West across the bridge. Follow Route 68 (Jefferson Street) into town. Continue straight across the Main Street intersection. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.

---

**From Route 68 West (Zelienople, Evans City):**

Take Route 68 East. Continue past Butler High School, down the hill toward the city (this is New Castle Street). Toward the bottom of the hill, stay in the left lane at the first light. At the very bottom of the hill at the second light, stay in the right lane through the intersection and follow the signs for Route 68 East (Cunningham Street) into the city. After the Washington Street intersection, the Tier Parking Garage is on the right,.

---

**From Route 8 North (Slippery Rock, Harrisville):**

Take Route 8 South past Clearview Mall and down the hill into the city. Turn right onto West Jefferson Street. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.

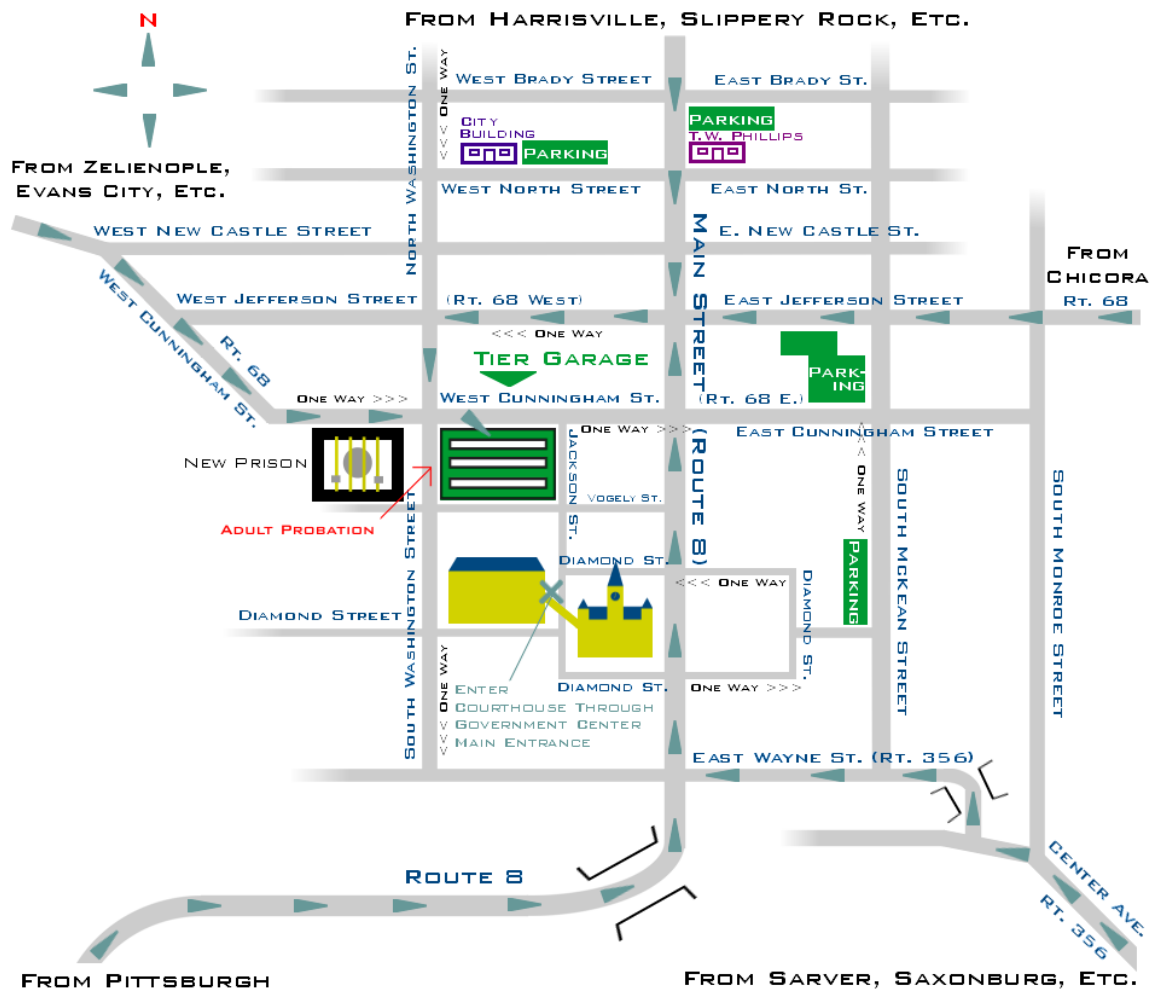
**From Route 356 South (Saxonburg, Sarver):**

Take Route 356 North down the hill onto Center Avenue (this is still Rt. 356). Follow the signs for Route 356 North to Main Street (Route 8) in the city. Turn right onto Main Street. Turn left onto West Jefferson Street. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.

---

**From Route 8 South (Pittsburgh, Mars, Cranberry):**

Take Route 8 North across the viaduct (bridge) into the city. Follow Route 8 (Main Street) north. Turn left onto West Jefferson Street. Turn left onto South Washington Street. Turn left onto West Cunningham Street. The garage entrance is on the right.



You must enter the Courthouse through the main entrance of the County Government Center, located behind the Courthouse, at 124 West Diamond Street. From there you can access the offices and courtrooms of either the Courthouse or the Government Center. There are officers in the lobby of the Government Center to assist you.

**The Adult Probation office is now located at 203 South Washington Street, the lower level of the Tier Parking Garage, across the street from the new Butler County Prison.**
